**Batani Fund was established at instigation of the board of RAIPON and Denmark's organization TGK Consult in August 2004, following the recommendation of the roundtable, which took place as part of the Saint Petersburg Economic Forum in June 2004**



**Mission of the Batani Fund: assistance to the indigenous peoples of the North in protecting their rights by distributing information, organizing educational activities and encouraging participation of indigenous peoples' representatives in political and economic life of the country and abroad**



The Fund's goal: cooperation of indigenous communities, industrial companies, state and local authorities to introduce and implement international norms and standards of indigenous peoples' rights in the Russian Federation



# SPECIAL CONSULTATIVE STATUS



At its main session in July 2008, the UN Economic and Social Council decided to assign the Special Consultative Status with the Economic and Social Council to the Batani Fund



# FUND'S EVENTS



**We have prepared and carried out 15 workshops and roundtables in 10 regions of the Russian Federation during last 4 years**

# MICROCREDITING PROGRAMME



During past two years we have allocated 14 loans to indigenous communities of Sakhalin, Sverdlovsk, Tomsk and Amur regions

# PROJECT MAIN RESULTS



Development of co-management bodies as a forum/site, where opinion of indigenous peoples is to be heard and potential conflicts can be solved before they become an obstacle

Analyses and development of methods evaluating the effect of industrial development on the indigenous peoples and their territories

Development and trial run of methods to train indigenous peoples to register and use traditional knowledge for mapping TTPs and conducting ecological monitoring

All analytic materials and methodic recommendations have been published in 8 books which can be used in other regions
